

Certificate of Interment Rights

The purchase price shall be paid in full at the time of purchase. All sales are final and binding by both parties.

1. The Memorial Garden was established for the direct interment of human cremains (with this process no container is used). Interment is open to all persons.
2. This certificate of interment rights conveys only a right to be interred in the interment space and in no way is any real estate title conveyed to the Purchaser.
3. The interment space is to be used for interment purposes only and the Purchaser's rights are limited by and subject to the Memorial Garden & Church Council rules and regulations as now existing or as amended in the future.
4. The Memorial Garden must receive the following information prior to any interment. The notice must include the name of the deceased, the deceased's birth date, the deceased's date of death, next-of-kin, and any other required information. The Church must be notified when the family wants the cremains interred and if a memorial service is desired, a minister will participate. If no service is desired, a representative designated by the church will be present for the burial. Please complete Interment Form at time of death.
5. The name of the interred will be engraved on the granite plaques. It will list name, birth date & death date of the deceased only. More detailed records will be kept in the Church office.
6. Cremains placed in the Memorial Garden are irrecoverable. At no time may the cremains be removed from the Memorial Garden after interment.

7. Out of respect for all persons, **absolutely** no flowers, plants or memorabilia (ie candles, stuffed animals, balloons, etc.) shall be placed in the Memorial Garden and surrounding area, with the exception of flower petals.
8. If a person who has purchased the right to interment in the Memorial Garden no longer wishes to maintain that right - **and their name has not been engraved on the Memorial Plaque**- the right is transferable with the written notification to the Memorial Garden committee. **No** refunds will be given.
9. The Memorial Garden is not a cemetery. The use and maintenance of the Memorial Garden is under the exclusive control of Hope Lutheran Church or its designees.
10. The Memorial Garden shall use the Purchaser's address for any official notices concerning the interment space. The purchaser shall notify the Memorial Garden of any change to their address.
11. The terms and conditions described herein are binding upon the Purchaser's heirs, successors and assigns and enforceable only by the Church Council or the Memorial Garden committee.
12. Memorial Garden Gifts and donations are accepted at any time.
